Edinburgh Group: Terms of Reference Final Version: 8 November 2023

The Edinburgh Group:

The Edinburgh Group (the Group) is an overarching pan-professional body of architectural conservation related professional institutes and organisations. It includes representative client and official UK and RoI heritage bodies and International interests. Its purpose is to assist in facilitating the roles, benefits, and developments of all member body Architectural Conservation Accreditation/Certification Schemes to enhance the operational competences of practitioners, this for the future well-being of the built heritage, its setting, and environment.

Initiated in 1999 by the activities of the *Scottish Accreditation Working Group* its mutually agreed remit evolved via a time-served *York Group* in 2002. It has been supported by COTAC since 2008. At its core is the acceptance, promotion and continuing relevance of the 1993 ICOMOS Education and Training Guidelines.

Aims:

The Groups' Aims are:

- to meet 6-monthly in May and November each year
- to help assure commissioning clients that Conservation Accredited/Certified practitioners have been peer-reviewed and determined 'competent' to practice in architectural conservation within their professional discipline.
- to help assure that mutually accepted professional 'equivalence' exists across all current and future built heritage conservation Accreditation/Certification Schemes

Objectives:

Representing the range of professional bodies and related organisation interests, the Group's mutually agreed objectives are to help:

- enable the various professional body peer-reviewed built heritage Conservation Accreditation/Certification Schemes to operate with common principles
- facilitate the transfer of relevant skills, knowledge, and experience in the field of Architectural Conservation

Intentions:

The Group's intention is:

- to encourage a continuing common approach towards the development, equivalence, monitoring and promotion of built environment conservation accreditation and certification schemes for individual practitioners on a pan-professional basis.
- to acknowledge the wider conservation context and related initiatives occurring within the sector.

Edinburgh Group: Working Remit

The Edinburgh Group will be inclusive of all relevant professional institutes and organisations that administer conservation accreditation schemes across the UK and the Republic of Ireland. It will also accept future representation from other bodies or organisations that devise and promote related accreditation/certification schemes in accordance with the Group's Aims and Objectives. (Note: In use of the joint 'accreditation/certification' term, 'certification' is adopted by RICS and CIOB to avoid confusion with their other established 'accreditation' schemes).

As appropriate, participation will include additional relevant parties, including engaging with individual professional Observers with a specific interest in accreditation developments, and who can contribute to the Group's intentions.

The Group's underlying principle will be to help assure commissioning clients that accredited practitioners have been determined 'competent' to practice in conservation work and activities by their professional body. This competence should be determined in accordance with the published and accepted '1993 ICOMOS Education and Training Guidelines' and through peer-review processes of their respective accreditation/certification scheme mechanism including acceptance of their 'Codes of Professional Conduct'.

In appropriate official grant-aided circumstances the accredited practitioners' assessment schemes and procedures should also be in accordance with the official UK Home Countries Protocol, dated December 2016 [attached at Annex A], and the related 2020 *ChurchCare Guidance Note on Commissioning Quinquennial Inspection Reports* [Extract attached at Annex B]

In pursuing the Group's approach, it will encourage pan-professional uniformity across the range of historic built environment accreditation/certification schemes to help:

- ensure a peer-reviewed consistency of approach, standards used and defined outcomes of original applications and subsequent re-accreditation
- refine and monitor the dependability of the various assessment processes
- maintain transparency and accountability in the processes
- increase the number of practitioners eligible for accreditation
- maintain a formal method of approach relative to deferral/refusal
- monitor the introduction and development of structured support CPD programmes
- encourage the creation of a pan-professional database of all accredited individuals
- promote endorsed lists of accredited practitioners.

In the application of these issues, the Group has previously reviewed the requirements of each Conservation Accreditation Scheme run by its member bodies and is regularly kept up-to date with associated developments during its six-monthly meeting cycle. This activity builds upon the May 2016 analysis of the *UK Conservation Accreditation and Membership Schemes for Professionals* compiled by The Council on Training in Architectural Conservation (COTAC) for Historic England.

Equivalence

A high degree of commonality already exists across the various UK and RoI in the operation of the various Conservation Accreditation/Certification Schemes and could form the basis of mutually agreed developments into a more formal recognition of 'Equivalence' in accredited status. This includes:

The need for the individual applicant to be:

- Pre-qualified in a professional discipline
- Appropriately Registered to practice

- Abiding by a Code of Professional Conduct
- Maintaining a CPD record of (focused) Conservation orientated study
- Appropriately knowledgeable and experienced skills commensurate with application
- Compiling and submitting a relevant CV with an emphasis on Conservation matters
- Conversant with the 1993 ICOMOS Education and Training Guidelines

The need for the accreditation process within the professional body to be:

- Peer reviewed and verifiable through informed and moderated Assessors
- Informed by a rigorous approach (including a Skills Matrix)
- Guided by and incorporating the ICOMOS E+T Guidelines
- Undertaking regular reassessments of applications
- Recognising the understandingconservation.org website support materials
- Offering a Complaints/Appeals process should that be required
- Complying with Data Protection legislation appropriate to the relevant country

Specifically, in pursuing the aim of achieving explicit *Equivalence* across the various Conservation Accreditation/Certification Schemes, the follow overarching principles apply:

- Applicants must be a suitably qualified and experienced member of their relevant Registering organisation and/or associated professional institute.
- Applicants must complete the necessary assessment as mandated by their respective Accreditation/Certification Scheme to demonstrate their level of competence.
- Assessments are measured against published Scheme criteria, all of which incorporate and adopt the 1993 ICOMOS Education and Training Guidelines for application and assessment purposes.
- Accredited Members must maintain appropriate membership of their Registration and/or host professional institute/body and abide by its Code of Conduct. Should they resign or retire, their related accredited status from that body will lapse.
- Applicants must provide evidence of relevant conservation orientated Continuing Professional Development undertaken in advance of their original application process and, subsequently, as part of a reassessment process.

The Group notes that some Schemes offer a tiered system, whereas others offer only one level. For clarity and the avoidance of doubt, it is considered that those at the highest level attainable for each Scheme are recognised as being 'equivalent' to each other and should be accepted as such by external bodies. [Current on-line Conservation Accreditation/Certification Scheme Guidance and Application documentation is listed in Annex C].

Complaints and Appeals

Whilst the collective Group aims to promote a mutual influence and direction across the range of accreditation/certification schemes on offer, each participating profession and body will maintain its own approach to ensure appropriate professional standards are upheld, effective monitoring of their scheme is pursued and that practitioners operate ethically in accordance with their profession or body's Code of Conduct, where each organisation will also be responsible for dealing with any associated complaints and/or appeals involved in upholding the quality and relevance of their scheme.

Annex A: Home Countries Conservation Accreditation Requirements. Agreed Protocol: December 2016

Requirement by the UK Home Countries Heritage Bodies for the lead professional role on their repair grant schemes to have conservation accreditation

Department for Communities Northern Ireland, Historic Environment Service (Cadw), Historic England and Historic Environment Scotland support the requirement for an applicant for their repair grants to employ a lead professional advisor with relevant specialist conservation knowledge, ability and experience.

The lead professional advisor is required to deliver a range of services relating to repair grants which are described in the grant application information. These include analysis of condition, investigations, planning and specifying the work, and inspecting and certifying the work while it is in progress and after it is completed.

To be recognised as eligible to be the lead professional adviser on their repair grants an individual needs to satisfy the UK Home Countries Heritage Bodies that:

- i. Their professional training and competences will enable the delivery of the services required of the lead professional in their grant schemes. &
- ii. Their conservation accreditation scheme meets the following criteria:
 - Accreditation of individuals rather than companies or practices
 - Schemes should be open to all suitably qualified and experienced members of the relevant professional disciplines
 - Assessment of a verifiable record of work carried out demonstrating experience and competence
 - Assessment by suitably experienced, impartial assessors against agreed criteria together with reassessment on a regular basis
 - The use of the ICOMOS Guidelines for Education and Training in the Conservation of Monuments, Ensembles and Sites
 - An ethical and linked disciplinary framework to ensure that standards are observed and maintained

Historic England and Historic Environment Scotland both operate this requirement on their repair grants. Cadw will introduce the requirement from January 2018. From April 2017, the Historic Environment Division of the Northern Ireland Department for Communities will have the same requirement for proposals seeking support of £10,000 or more from its Historic Environment Fund.

Background

Conservation accreditation schemes for professionals are developed and operated by professional bodies and independent organisations. Each scheme has its own application and assessment process. Becoming accredited involves submitting evidence of an individual's experience and competence, which is assessed by suitably experienced and impartial assessors. Most schemes use the International Council on Monuments and Sites' (ICOMOS) Guidelines for Education and Training in the Conservation of Monuments, Ensembles and Sites as the basis for their assessment of candidates' experience. However, the schemes vary in their entry and re-accreditation requirements.

Guidance Note Page 2 Extract: Highlighting Conservation Accreditation Requirements

Appointment of a Quinquennial Inspector

The appointment of a Quinquennial Inspector is made by each PCC, and is always of an individual, not a firm. The appointment is for one inspection and report in the first place. It is important that a Quinquennial Inspector's **training**, **accreditation** and **experience** in building conservation is commensurate with the complexity and significance of the church building(s) in question.

Criteria for appointing a suitable person to the role of Inspector

• Competent to inspect Major Churches (as defined by the CBC) which includes what used to be Greater Churches; proven experience of working with such large and/or highly significant and complex church buildings is recommended, at least at a junior level under a more experienced professional; and experience of working on Grade I or II* church buildings in a sole capacity. Relevant accreditation would normally be required, and always for professionals undertaking their first Inspector role.

- Competent to inspect Grade I or II* churches; proven experience of work in a sole capacity
 with listed buildings; proven experience of work with such highly designated church
 buildings at least at a junior level under a more experienced professional; preferably
 experience in sole capacity. Relevant accreditation would normally be required, and
 always for professionals undertaking their first Inspector role.
- Competent to inspect **Grade II churches**; proven experience of work in a sole capacity with listed buildings; preferably experience of working with listed church buildings at least at a junior level under a more experienced professional. Relevant accreditation would normally be recommended, and always for professionals undertaking their first Inspector role.
- Competent to inspect unlisted churches; no specific prior experience expected, but evidence of supervision from an experienced professional with experience of church buildings is recommended. For certain buildings, evidence of experience of working with traditional materials may be required.




